Biden signs into law ban on Russian nuclear reactor fuel imports



The International Press: The ban on imports of the fuel for nuclear power plants begins in about 90 days, although it allows the Department of Energy to issue waivers in case of supply concerns. Russia is the world's top supplier of enriched uranium, and about 24% of the enriched uranium used by US nuclear power plants come

from the country. The law also unlocks about \$2.7 billion in funding in previous legislation to build out the US uranium fuel

"Today, President Biden signed into law a historic series of actions that will strengthen our nation's energy and economic security by reducing, and ultimately eliminating, our reliance on Russia for civilian nuclear power," Jake Sullivan, the national security adviser, said in a statement

Sullivan said the law "delivers on multilateral goals we have set with our allies and partners," including a pledge

last December with Canada, France, Japan and the United Kingdom to collectively invest \$4.2 billion to expand enrichment and conversion capacity of uranium The waivers, if implemented by the Energy Department, allow all the Russian uranium imports the US normally imports through 2027. results. "The delicate balance between exporters and importers of uranium products is being disrupted," the Russian embassy in Washington cited Antonov as saying in a post or its Telegram messaging channel

Principal Scientific Adviser to the Gol Chairs Meeting to Discuss Biomass Cultivation on Degraded Land for Green Biohydrogen Production

The International Press : Principal Scientific Adviser (PSA) to the Government of India, Professor Ajay Kumar Sood, convened the first meeting to discuss biomass cultivation on degraded land for green biohydrogen production and bioenergy generation today (May 14, 2024) at Vigyan Bhawan Annexe,

New Delhi. The meeting brought together key stakeholder government ministries, knowledge partners, and research institutes to explore the utilization of degraded, barren, and uncultivated lands for biomass cultivation. This biomass will be used to produce green biohydrogen, initiating a

comprehensive discussion series among stakeholders to prepare an action plan for enhancing green hydrogen production from biomass. In his opening address, Prof. Ajay Kumar Sood said that one of the objectives of the National Green Hydrogen Mission is to initiate focused pilots for biomass-based green

biohydrogen production. Therefore, it is important to understand the biomass cultivation ecosystem of the country. Prof. Sood highlighted that the meeting aims to gather inputs on biomass and degraded land availability, identify gaps and challenges in biomass cultivation, and

strategize a roadmap for using degraded land for green hydrogen production. Dr. Rajesh Gokhale, Secretary, Department of Biotechnology (DBT), presented prospects for seaweed cultivation as biomass for bioenergy production and fostering a start-up ecosystem to boost marine biomanufacturing, aligned with India's Deep Ocean Mission. This was followed by a presentation from Dr. A. Velmurugan, Additional Director General (Soil & Water Management), Indian Council of Agricultural Research (ICAR), on biomass production for green energy using various

plants, including algae, molasses, and sugarcane. Dr. Sangita M Kature, Adviser, Ministry of New & Renewable Energy (MNRE) highlighted the various programs at the ministry for bioenergy and also talked about National Biomass Atlas for agriresidue surplus data. Dr. G. Sridhar, Director General, Sardar Swaran Singh National Institute of Bio-Energy (SSS NIBE), MNRE, highlighted the role of agri-residual biomass in the context of green hydrogen, discussing the availability of surplus biomass and its potential for energy production. Dr. Prakash Chauhan,

Director, National Remote

Organisation (ISRO), delivered a presentation on 'Bhuvan portal for data on biomass availability from agriresidue and data on degraded Land Mapping. Dr. Chauhan emphasized the need for data on characterization of biomass for understanding the potential of biomass. Sh. Neelesh Kumar Sah, Joint Secretary, Ministry of Environment, Forest & Climate Change, highlighted government policies and programs addressing land degradation neutrality. Sh. Nitin Khade, Joint Secretary, Department of Land Resources, focused on using spineless cactus for green hydrogen production. The final presentation by Sh. Hrushikesh Barve from Gokhale Institute of Politics and Economics discussed the 4F-BioEconomy framework for land restoration and biomass cultivation. Industry experts and key government officials from various ministries, including the Ministry of Petroleum and Natural Gas; Ministry of Mines; Ministry of Power; Ministry of Road Transport & Highways; Ministry of Ports, Shipping & Waterways; Ministry of Railways; Ministry of Agriculture & Farmers Welfare; and Department of Land Resources provided their

inputs on various schemes under their departments for biomass cultivation and production of hydrogen. Dr. Parvinder Maini, Scientific Secretary, Office of the Principal Scientific Adviser to the Government of India, summarized the meeting's outcomes, emphasizing the need for biomass cultivation in land as well as in marine ecosystems. Dr. Maini highlighted the importance of R&D on generating more biomass with less resources like water, specifically in the context of Napier grass, energy cane, and cactus Prof. Sood concluded by re-emphasising the need to identify biomass for cultivation and identification of government-owned land available with ministries/ departments for cultivating biomass for the purpose of enhancing hydrogen production in the country. Prof. Sood mentioned that this approach of utilizing both public and private land for sustainable biomass cultivation would meet the country's energy demand, reduce dependency on fuel imports, generate revenue, and significantly contribute to bioenergy production. He stressed that biomass cultivation for bioenergy should be sourced and processed sustainably and costeffectively while maintaining local environmental biodiversity.

The fraudsters are known to use studios modeled on Police Stations and Government offices and wear uniforms to

appear genuine.

money to such criminals. This is an organized online economic crime and is learnt to be operated by cross-border crime syndicates. The Indian Cyber

Crime Coordination Centre (I4C), under the Ministry of Home Affairs, coordinates activities related to combating cybercrime in the country. MHA is closely working with other Ministries and their agencies, RBI and other organizations to counter these frauds. I4C is also providing inputs and technical support to Police Authorities of States/UTs for identifying and investigating the cases. I4C has also blocked

more than 1,000 Skype IDs involved in such activities, in collaboration with Microsoft. It is also facilitating blocking of SIM cards, Mobile devices and Mule accounts used by such fraudsters. I4C has also issued various alerts through infographics and videos on its social media platform 'Cyberdost' for e.g. X, Facebook, Instagram and others. Citizens are advised to



This is in continuation of Commission's transparency initiative of giving out MCC updates after first month of its coming into effect. Certain details of action taken, were also given out so that misgivings, however small or limited, are addressed and stopped.

So far, 25 delegations from 16 political parties have met the Commission to lodge their grievances/ complaints on alleged violations of Model code. Apart from this, many delegations have met at the level of Chief Electoral Officer in the States. 7. All political parties have been promptly allocated time even at short notice and their

grievances patiently heard. 8. Approximately 425 major complaints excluding canvassing related or clarificatory complaints have been filed by various political parties and candidates at the level of ECI and CEOs. Of these, action has been taken (or matter disposed) in 400 cases. Approximately 170, 95 and 160 complaints were filed by INC, BJP and

Others respectively. Most of these complaints have been acted upon. 9. A few complaints of INC and BJP against divisive statements by top Star campaigners on communal, caste, regional language divide, or on sanctity of Constitution of India. In the past, the Commission has been issuing notices to individual leaders who had committed violations of MCC. Commission has adopted a new course with its advisory

dated 01st March 2024 to Party Presidents/Chairpersons/General Secretaries of all recognised political parties urging them to ask their leaders/candidates/star campaigners not to make speeches/ utterances which are in direct or indirect violation of MCC. The Commission has taken a view that while the individual star campaigner/leader/candidate would continue to remain responsible for speeches made, the Commission will address Party President/Head of the political party, on case-to-case basis, as the Parties have prime responsibility to rein in their star campaigners from committing such violations. The purpose is to raise the accountability of the political party in compliance of MCC by all their cadres. Notices have been issued to presidents of both the parties in case of these pending complaints. Response from both parties has been received. Appropriate action on complaints/counter complaints is under examination/ consideration of the Commission. Some prominent actions taken under MCC framework are given in



Kohli's career hit new heights at the ICC Men's Cricket World Cup 2023, where he topped the run charts with a record tally of runs. The stalwart batter walked away with the Player of the Tournament award despite coming into the event with his best years seemingly past him, and after an extended period where his frequency of making triple-digit scores reduced.

Kohli has set his eyes on the coveted trophy at the upcoming ICC Men's T20 World Cup 2024 and will

be featuring for the sixth time in the tournament. His first-ever appearance at the T20 World Cup was in 2012, five years after India achieved their only title win in the format.

Yuvraj said that Kohli deserved another World Cup medal after 2011, where he was part of the title-winning Cricket World Cup campaign.

"He has definitely broken all the records in this era,' Yuvraj said in a chat with

"The best batter of this generation, I feel, in all formats. And I think he is also someone who needs a World Cup Medal. He has one. I'm sure he is not satisfied with one. I think he surely deserves that medal as well." Kohli's penchant for big knocks under pressure is

well known and the T20 World Cup has witnessed some of his most impactful knocks, most notably two vears back at the Melbourne Cricket Ground, where he awed over 90,000 spectators with a finish like none other against arch-rivals

Pakistan.

But the tournament has witnessed Kohli at his peak way earlier. In the 2016 edition of the tournament, Australia bore the brunt of Kohli's ravishing form when he put on an exhibition at chasing targets down. An unbeaten 82 off 51 balls in a run-chase of 161 put India in the semi-finals of the tournament.

"I think he understands his game really well," Yuvraj "He knows if he's there till

the end, he is going to win

the game for India and he has done that on some big occasions - against Australia in Mohali as well. "Once he had the

confidence of chasing and knowing the situation, he knows how to bat in these situations, knows which bowlers to attack, which bowlers to take singles off, when to attack again, handle the pressure and knows when to change his

memorable for two of the best knocks the tournament has seen, Kohli's best run came in the 2014 T20 World Cup, where he made the most runs he has made in any edition of the tournament. Kohli made four halfcenturies in six matches in the tournament that year and Yuvraj, who witnessed

Head says IPL form no guarantee for T20 World Cup success



The International Press: Travis Head has decimated bowling attacks in the Indian Premier League (IPL) this year but the Australian tempered expectations ahead of next month's Twenty20 World Cup in the West Indies and United States, where turning tracks could make batting tougher. Sunrisers Hyderabad batsman Head has scored 533 runs in 11 IPL matches so far, with only Virat Kohli (542) and Ruturaj Gaikwad (541) above him, and the 30year-old's aggressive approach has marked him out as one to watch at the June 1-29 World Cup. He hit an unbeaten 30-ball 89 as Hyderabad thumped Lucknow Super Giants by 10 wickets with 62 balls to spare on Wednesday, but Head said his blistering form on flat Indian wickets would not automatically translate to similar pyrotechnics elsewhere. 'Whenever you're playing, you want to be as consistent as you can, you want to be getting runs. It's nice to be playing well (but) that's not going to guarantee anything in the West Indies," Head told

"I think we'll face a fair bit of spin in the Caribbean and the wickets might become tougher as the

tournament goes on. "I'm very pleased I was able to play spin tonight and the things I'm working on in training are somewhat working at the moment. But I'm trying to stay relaxed as I have done for the last couple of years and be ready to go.' Hyderabad, who posted the biggest IPL total earlier this season with 287-3 against Royal Challengers Bengaluru, chased down Lucknow's total and finished with 167 for no loss - the highest 10-over score in men's T20 cricket. Head's opening partner Abhishek Sharma made an unbeaten 75 from 28 balls, with the duo smashing a combined 14 sixes and 16 fours.

"I'm lost for words," Lucknow skipper KL Rahul said. "We've watched that kind of batting on TV, but this was unreal." Third-placed Hyderabad's seventh win in 12 games kept them firmly in the hunt for the playoffs, while the result ended the hopes of five-times champions Mumbai Indians

Scamacca has had an upand-down first season back in Italy with Atalanta but is in the form of his life on the eve of Thursday's second leg of their Europa League semi-final with Marseille. The 25-year-old has scored 10 times and set up another in his last 12 matches, and his fizzing low finish last week ensured Atalanta came away from the Stade Velodrome with a 1-1 draw after having their backs to the wall for large parts of the first leg in southern France. He will be the focal point of Atalanta's exciting attack in front of passionate home fans in Bergamo who have once again seen their traditionally provincial club punch way above its weight Scamacca has scored 18 goals in all competitions this term with the bulk of those strikes coming after he was left out of the Italy squad for March's friendlies with Venezuela and Ecuador. He was dumped by Luciano Spalletti after the Azzurri

coach, in a February interview with the Gazzetta Dello Sport, blasted footballers "playing on the PlayStation until four in the morning" Spalletti named no names in

an unexpected tirade against modern players' apparently flagging commitment to football but eyes immediately turned towards Scamacca, who was left out despite Italy having a long-standing problem of finding reliable strikers.

Scamacca, from Rome, has

a roughneck presence due to his size and array of tattoos and has had to deal with embarrassing headlines involving his family. In March 2021 his estranged father smashed up cars ncluding one belonging to the police -- outside Roma's training ground for no apparent reason and a few months later his grandfather burst into a bar in Scamacca's childhood neighbourhood of Fidene and threatened people with

"I've had to deal with prejudice since I was 16years-old but I know what kind of person I am, and I only need to show it to the people who care about me. Scamacca said after scoring in Atalanta's 3-0 win at Napoli in March. "I don't give any importance

to chit-chat and rumour. Scamacca's form has come at a perfect time for both club and country, as Italy defend their European Championship title in Germany this summer after missing out on a second consecutive World Cup. Atalanta meanwhile, whose trophy cabinet contains seven lower league titles and the 1963 Italian Cup, are looking to go one better than in 1988 when they reached the last four of the Cup Winners' Cup as a Serie B team.

Gian Piero Gasperini's side have, like Scamacca, been inconsistent for much of the season but are eyeing a historic climax to the campaign, with a Italian Cup final with Juventus coming up next week and Champions League qualification also up for grabs.

Scamacca netted in Atalanta's hard-fought win at relegated Salernitana on Monday which moved his team into Serie A's fifth and final spot for Europe's elite club competition.

The next fortnight will decide

whether Atalanta finally win

a trophy which would be just reward for years of investment and development which have taken Atalanta from nowhere to the brink of European glory.
